

2020 CONSTITUTION PARTY OF VIRGINIA VIRTUAL STATE CONVENTION CALL

I, John Bloom Chairman of the Constitution Party of Virginia issue this Quadrennial VIRTUAL State Convention for the Election of State Officers, Chairman, Vice Chairman, Treasurer and Secretary as well as Two AT LARGE State Representatives and one State Representatives for each of the 11 Congressional Districts. In addition this State Convention shall nominate candidates for next year's PUBLIC Offices. This includes Governor, LT, Governor, Attorney General and all 100 State Delegates throughout the state of Virginia. Selecting our slate of candidates would allow us the opportunity to start collecting signature the very first day we are allowed to be State Law, 1/1/2021. The meeting will use ZOOM or freeconferencecall.com and if you have a webcam you can see everyone. If you have difficulty running Zoom on your cell phone or PC, the system also allows one to call into the Conference. The reason I have Paul also receive the application is I want to ensure all members are confidence that all applications are received and confirmed. This will be a fair, open and honest Convention. Nominations from the floor will only be allowed if no one applies for the Public or Party Position (NOTE, Federal Employees are ineligible to be Party Treasurer or run for Public Office, members of the military on active duty are prohibited from being active in a political party/events, I encourage their spouses to represent their household and participate in this Virtual Convention).

All CONTESTED Party Offices will be voted on 1st, with non-contested positions being voted on by Acclamation (Voice vote). If TWO or more people apply to be a CD Representative in the same CD, they would be considered for the AT LARGE Representative and a voice vote may be taken to increase the number of AT Large representatives, if there are more people applying to be a CD Representative to allow maximum participation in the Party. The AT Large Representatives will be Nominated from the floor if there are no contested CD Seats. According to State Law all Delegates are required to live in the State Delegate District they would represent.
